Preface

The year 2019 saw no improvement in the Human rights situation for the people in Pakistan's restive province of Balochistan. Enforced disappearances, arbitrary arrests, target killings and military operations continued unabated and with impunity.

We have received partial details of 568 cases of enforced disappearances and 241 killings during the year 2019. Most of the forcibily disappeared persons were from Awaran, Gwadar, Kech, Khuzdar and Pangur districts of the province. Meanwhile the other twenty-seven districts of the province were not accessible to us due to continued military operations and blockade of communication networks.

Students remained a main target of military and the military backed death squads during the year 2019, as majority of the forcibily disappeared persons during the year were students.

In one of a blatant rights violations of the students, secret video cameras were found installed in the main university of Balochistan to record candid moments. Cameras were discovered in washrooms and other private places in girls hostel of the university. The recordings were used in blackmailing students. The government formed parliamentary commission played a waiting game until the issue was pushed out of the news by other human rights violations such as the forced evacuation of female students from the Bolan Medical college. We believe the issue of students' recordings and harrasment would be put in the cold with no conclusive results coming out of the so called investigations. The reasons of this ignorance can be better understood by the fact that the university is under the control of the powerful military for years and all initial proofs point toward military's involvement in these harrasment cases. The university itself is declared as a sub campus of army's Frontier Corps.

None of the enforced disappeared persons were charged of any crime or illegal activity in front of any court. All the 568 persons remain disappeared and the families are unaware of the whereabouts and condition of the missing persons.

Below is the month-to-month detailed reports for the year 2019.

January 2019

77 disappeared and 18 extra judicially killed:

According to the details security forces forcibly disappeared 77 persons from Awaran, Kech, Khuzdar Panjgur, Gwadar and Sibi districts of Balochistan. Whereas the rest 26 districts of Balochistan still remain inaccessible due to the media blockade introduced by authorities in Balochistan to suppress the voices raised against the violations committed by the forces.

On the other hand, ten decomposed beyond recognition bodies were brought by Edhi foundation to Teramil Graveyard, Dasht for burial on 08th January 2019. The bodies were buried without DNA analysis. The burial of the bodies without DNA analysis have caused anguish to the families of victims of enforced disappearances who have been sitting on a hunger strike in front of Quetta Press Club.

The victims of enforced disappearances include Muhammad Azeem s/o Phullan resident of Gubord, Mand district Kech. According to the locals Muhammad Azeem is a farmer and was working on the fields when security forces raided and abducted him on the evening of 02nd January 2019.

On 01 January 2019, Mohammad Ali s/o Abdo was whisked away by security forces from a military check post in Tirtej, Awaran. Family members say, Mohammad Ali was travelling back from Karachi in his truck along with a driver and a conductor. They were held in the check post and after a few hours both the driver and the conductor were released whereas the whereabouts of Mohammad Ali still remain unknown.

Rashid s/o Abdul Rasool was forcibly disappeared by the forces during a raid at his house at around 1:00 am. According to his extended family, Rashid was working as a

labor in Middle East and was recently back home on holidays when he was abducted from Mondi area of Gwadar.

On 19th January 2019, personnel of Frontier Corps (a paramilitary force) accompanied by personnel in civil dress, raided the house of Abdul Rasool and abducted his 17 years old son Jaffar.

On 27 January 2019, forces conducted a search operation in Dasht Sadi, a village near Pakistan-Iran border, district Gwadar and forcibly disappeared Ghani s/o Abbas. Women and children were beaten up.

On 28 January 2019, Salman s/o Dad Rehman and Malik s/o Mohammad were abducted from Nizarabad, Tump district Kech. Salman was abducted from his own shop which is locally famous as Salman's shop whereas Malik s/o Mohammad was abducted during the exams from the examination hall.

On 31 January 2019, security forces conducted a military operation in Gwarkop area of district Kech. Eight persons were abducted, including four of the same family.

Abductees are Solo s/o Babu, Rasheed s/o Kamalan, Qamber s/o Yousuf, Muneer s/o Wali Mohammad, all from same family, Hasil and Musa Wahag are two brothers while Basheer and Sabzal Qadir Bakhsh are brothers.

70 persons were released from the custody of security institutions during the month, many of them were missing for years and some for months.

Eighteen persons were killed during the month of January, eight of them died from firing of unknown persons in Kech, Panjgur, Sibi and Quetta districts of Balochistan.

On 03 January 2019, a dead body was found dumped in Hub Chowki, district Lasbela. The deceased was later identified as Elahi Bakhsh Pir Jan resident of Dulechi Jhao district Awaran. Elahi Bakhsh was abducted by Pakistani security forces from Jhao,

district Awaran on 07 May 2016. His whereabouts remained unknown till his body was found dumped in Hub, Balochistan.

On 7th January, a mutilated dead body was found in a sack on the eastern bypass in Quetta, the capital city of Balochistan. The dead body was later shifted to a hospital for identification. Later the deceased was identified as Shokat Ali s/o Saleh Mohammad, a resident of Musa Colony, Quetta whereas his hometown was Kardagap, Mastung. According to local sources he was a student in Degree College and was also working as a dispenser in Yaseen Hospital Quetta. He went missing on 06 January after leaving the house.

On 9 January, another body was found in Saryab Mill Colony, Quetta. The body was shifted by Edhi foundation to the hospital where he was identified as Mohammad Arif s/o Lateef Mastoi. According the doctors he died from a gunshot.

On 11 January, a dead body was found in Sangsela area of Dera Bugti. Levies accompanied by personnel of Frontier Corps shifted the body to the local hospital where he was identified as Shehan Bugti.

Phulan Waju was killed and claimed by Balochistan Liberation Front (BLF) in Awaran on 19th January 2019. Spokesperson of BLF claimed the responsibility and stated that Phulllan was an informer of the military.

Balochistan presents a picture of a war zone, where the state military is confronted with the armed men, belong to nationalist armed groups. The armed groups emerged when the central government pushed the local nationalists to the wall, when they demanded more autonomy and rights on the natural resources of the land, Balochistan. During the military rule, in late 1990's, central government pressed nationalists and started suppressing the voices raised against the newly announced projects, especially a multibillion dollars project China Pakistan Economic Corridor. Gradually the armed resistance gained momentum and the civilian population is caught between states military, armed nationalists and religious extremists.

February 2019

46 disappeared, 17 killed:

According to the details security forces abducted 46 persons from Awaran, Chaghi, Dera Bugti, Kech, Khuzdar and Gwadar districts of Balochistan whereas rest of the 26 districts remained still inaccessible due to the media blockade and systematic anti-prosperity policies introduced by authorities to further suppress the voices raised against the grim human rights situation in Balochistan.

The victims of enforced disappearances include Dad Allah Ameen and Nawaz Dostain abducted along with Ahmad Yar Mohammad and Shaho Ameen from Talamb area of Mand district Kech on 1st February 2019. Locals say: "When forces raided, women and children were also beaten up and they forcefully disappeared Dad Allah, Nawaz, Ahmed and Shaho". Ahmed and Shaho were released on the following day whereas the whereabouts of Dad Allah Ameen and Nawaz Dostain remain unknown.

On the same day Ishaq Ibrahim and Raheem Dad Umethaan were abducted from Jathani Bazar, Dasht district Kech and Maqbool Ahmed s/o Lal Mohammad, a 16 year old minor and a resident of Kharan, Balochistan, was forcefully disappeared from Dalbandin district Chaghi.

On 6th February, forces arrested a student of engineering in Balochistan University of Engineering and Technology from his hometown of Dera Bugti. Mohammad Ali Bugti was arrested by forces from Gol Chowk in Dera Bugti. It is the second time he is being forcefully disappeared by forces. He was first abducted from Quetta, the capital city of Balochistan on 14th December 2018 and was released after two days of incommunicado detention.

On 13th February, a young student Naseem Dilmurad was forcefully abducted by security forces from Apsar area of Turbat, Balochistan. Naseem is a resident of Bolor, Kolwa district Awaran. General Secretary of BHRO Abdullah Abbas Baluch tweeted on the matter and further said "Despite promises of Balochistan government to release enforced disappeared persons, forces are continuously abducting innocent civilians". Naseem's whereabouts are still unknown.

On 15th February, Shah Bakhsh Noor Bakhsh and Dad Shah Ishaq were abducted by security forces during a raid on Jalagi, Zamuran district Kech.

On 16th February, Sattar Dilwash and Shabbir Gul Mohammad were abducted during a house to house search operation in Goburd, Mand district Kech.

Pakistani security forces conducted a military operation on Sorger area of Jahoo district Awaran. During the military operation two confirmed cases of involuntary abduction were documented by HRCB and BHRO. The abductees were identified as Sohrab Huzoor Bakhsh and Fateh Mohammad Huzoor Bakhsh.

36 persons were released from the custody of security forces during the month of February 2019. Many of the released persons were missing for years, some for months whereas some were abducted in the same month and then got released.

Thirteen persons were killed during the month of February. A total of 3 persons were killed in different incidents of firing. Seven dead bodies were found dumped in different areas of Balochistan whereas two unknown persons were killed in a bomb blast in Dera Murad Jamali and a civilian died in a mine explosion in Dera Bugti, Balochistan.

On 1st February, Asif s/o Shapuk was targeted when a car full of armed men opened fire and killed him. The perpetrators later escaped from the crime scene.

On the same day another incident was documented in Sabzal Bugti Goth district Sohbatpur where a civilian Mehrullah Bugti was targeted and killed by unknown gunmen.

According to the reports, Idrees Qamabrani Mohammad Ayoub was abducted by unknown persons and a few days later on 4th February his bullet riddled body was found dumped in Killi Zarozi district Kharan. The body was shifted to a hospital and after identification his body was handed over to the family.

On 5th February, another dead-body was found dumped in Zehri district Khuzdar. The body was shifted to a hospital and later handed over to the family. The deceased was identified as Niaz Shahwani.

On 12th February, a mutilated dead-body was found in Saeedabad, Ormara district Gwadar. According to the locals, Talaho Jumma disappeared 6 months ago and despite efforts to find him his whereabouts remained unknown till his dead body was found. On 21st February Pakistani security forces abducted Gwahram Basham, Muhammad and Siraj from Heronk district Kech. Later, on 23rd February forces Brought Gwahram Basham's tortured dead body to the hospital and buried him without informing the family and against their will whereas whereabouts of Mohammad and Siraj still remain unknown.

Sher Jan s/o Mohammad Bakhsh was abducted by unknown personnel with his motorbike in Dat, Ornach district Khuzdar on 23rd February. After two days his deadbody was found dumped near a roadside with his motorbike. The perpetrators remain unknown so far.

March 2019

Sixty persons were forcibly disappeared, 20 killed:

On 23 March 2019, forces picked up two more women, Bibi Hoori and Jan Bibi from their houses in Gajjali village of Mashkey, district Awaran. Their whereabouts are still unknown.

A well-known Balochi writer and author of five books including three novels, Nazar Mohammad was abducted by security forces on 5 March, 2019. He is a serving sergeant in the Royal Oman Army, in Sultanate of Oman. He was on his vacations and reached Turbat on 26 January, 2019, to spend his vacations with his family and friends and was supposed to resume duty on 20 March. Since then his whereabouts are kept unknown.

A reporter, Niamatullah Baloch was whisked away by security forces in Taftan region of Balochistan on 6 March.

A police trainee, Shakoor Babu was abducted when he was on his way to the police academy in Turbat, Balochistan, the district headquarter of district Kech, on 3rd March. Shakoor is a local of Nodiz, district Kech.

In another case, two brothers, Nasim Nazeer and Shay Murid Nazeer were abducted during a raid on a house in Karachi on 1st March 2019. Abductees are residents of Nizarabad, district Kech.

A father and his son were forcibly disappeared during a military operation in Dannuk, Turbat on 4th March. Earlier, he migrated from Dasht to Turbat to save his family from continuous and indiscriminate military operations in the area.

Fazul Mohammad, Zahur Siddique and Ghulam Nabi Mola Bakhsh were abducted on 5 March by security forces from Shangar, district Washuk.

Shay Dinar was abducted during a raid in Gwarkop district Kech on 12 March

Unknown gunmen abducted Munir Ahmed Bazid from Lasbela University on 14 March. Eyewitnesses say he was severely beaten up during the abduction. The reason behind abduction and whereabouts of Munir are still unknown.

Noor Ahmed Niaz was forcibly disappeared by security forces from Shehani Bazar, Turbat on 16 March. According to his family, he was picked up by security forces from a local shop and since then his whereabouts are unknown.

On 17 March, forces conducted a house-to-house search operation in Sholi and Parant villages of Dasht, district Kech and abducted 6 persons. The abductees were later identified as Faqir Ahmed Khuda Dad, Tariq Shafi Mohammad, Rafiq Lal Bakhsh, Rahim Bakhsh Lal Bakhsh, Umetan Rahim Bakhsh and Salim Abdul Rahim.

On the same day, Sharif Fazal was abducted from Pirandar village of district Awaran while four persons, Akbar Khuda Bakhsh, Islam Khuda Bakhsh, Abdul Wahab and Abdul Khalid were whisked away from Sirkezeh village of Zamuran, district Kech.

A retired soldier of the Royal Oman Army, Neksal Miran, was abducted along with Gulab Karim Bakhsh and Zahur Soban during a military raid in Tash, Balgatar, district Panjgur on 19 March.

Thirteen mutilated bodies were found in different areas of Balochistan during the month of March in which 8 dead bodies were later identified whereas, 7 bodies were decomposed to the extent of beyond recognition. Moreover, seven persons were killed in target killing including a polio worker.

On 1st March, Murid Bezanjo was killed by unknown militants in Ornach, Khuzdar. Later on, Balochistan Liberation Front, in a statement, took the responsibility of the attack and claimed he has collaborated with army in several military operations and facilitates attacks on our camps.

On 4 March, a dead body was found dumped in Mian Ghundi area of Quetta. The deceased was later identified as Nasib Ullah Khelji s/o Malang Khan. According to the

family members, he was abducted two weeks ago from Gahi Khan Chowk, Quetta. Both, the reason and the perpetrators remain unknown.

Tortured dead body of an 8-year-old child was found dumped in Pashin. According to the police, the deceased body bore clear marks of torture and his body was dumped in a sewerage line on 6 March

Another decomposed body was found in Satellite Town, Quetta on 6 March. The deceased was later identified as Sanaullah Dur Mohammad. The reason and the perpetrators remain unknown.

On 8 March, an unidentified body was found dumped in Kanak, Mastung. The dead body was later shifted to the hospital and still remain unidentified. Another unidentified decomposed body was found from Dera Murad Jamali on 14 March.

On 16 March, two decomposed dead bodies were found dumped in Quetta and Zhob. On the same day, a polio worker was shot killed by unknown gunmen in Pashin. According to the locals, the killers came in a Toyota Veto car and opened fire on the polio worker and escaped from the scene.

On 22 March, another unidentified dead body was found dumped in Ghousabad area of Quetta, the capital city of Balochistan.

On 23 March, three mutilated dead bodies were found dumped in Dera Ismail Khan, a Baloch majority region in Punjab province of Pakistan. Bodies were identified with their identity cards, kept in their pockets. It has once been a norm that the dead bodies beyond recognition would have his NIC or his name written on a small piece of paper, in his pocket.

April 2019

59 disappeared, 40 killed:

In the month of April, fifty-nine persons were forcibly disappeared by security forces from Awaran, Kech, Gwadar, Lasbela, Panjgur districts of Balochistan. Forty people were killed in April including victims of Hazar Ganji bomb blast which left twenty dead and 48 wounded.

Majority of the districts in Balochistan remained inaccessible.

Abduction and enforced disappearance of women and children continued in the same pace. On 30 April, security forces raided Shehaq Bugti's house in Rabi, Naseerabad and abducted five women and 4 children. The victims were later identified as Dhando Ratta Bugti, Shozan Shehak Bugti, Bujari Bibi Shehak, Pati Karim Bugti, Jamil Karim, 6 years old Batte Khan Shehak Bugti, Zargul Shehak, 3 years old Amina Bibi Shehak and Noor Banuk Shehak.

On 1st April, security forces raided several houses in Tijaban, Singabad district Kech and abducted nine civilians. Abductees were identified as, Musa Bujer, Rafiq Ahmed, Trongal Zabad, Amir Bakhsh Zabad, Wahag Musa, Gulab Musa, Patan Musa, Bahot Mia and Faiz Mohammad Nawab. Rest of the abductees were later released by the forces, except Rafiq Ahmed and Ameer Bakhsh Zabad. Their fates and whereabouts remain unknown to this day.

On 5 April, security forces started a house-to-house search operation in Kohad area of district Kech and abducted seven persons, Haibthan Abdi, Niaz Qadir Dad, Rashid Dilmurad, Mehran Rasool Bakhsh, Izzat Khursheed, Hameed Shahdad and Siddique.

In another incident on 06 April, a fourteen years old boy, Samir Nasrullah Notezai was abducted by unknown armed persons, driving a Vigo car, from Faisal Colony, Dalbandin. On the other hand, Pakistani security forces and personnel of intelligence agency whisked away Asfandyar s/o Abdul Karim from Nushki, Balochistan on the same day. On 18 April, security forces raided the house of Dilmurad Dur Mohammad in Rais Goth, Karachi and forcibly disappeared his three sons, Hanif, Hafiz and Hamid. On the same night forces raided the house of Mohammad Ayoub in Hub Chowki and whisked away his sons, Parvez Jumma, Zakir, Altaf and Bahadur. Their whereabouts are still unknown. All of the abductees are residents of Awaran, Balochistan and migrated from Awaran few years ago because of the ongoing military offences in the area.

On 25 April, forces abducted seven civilians from Tank area of Mashkay district Awaran during a military operation. The victims were identified as Bahram Ali Jan, Gulab Mohammad Omar, Naseer Khan Mohammad, Musharraf Naseer, Khan Bagi, Gulab Sohrab and Rustom.

Five mutilated bodies were found in different areas of Balochistan during the month of April. two women were killed in honor killing, twelve persons were killed in target killing and encounter between armed forces and separatist groups, one case of extra-judicial killing. 20 civilians lost their lives in a bomb attack on Hazara community in Quetta, Balochistan on April 12. ISIS claimed responsibility of the bomb attack.

On April 25, Hazoor Jatt's bullet riddled body was found dumped. He was arrested by security forces on April 22 from Notal, district Naseerabad.

Abductions, extra judicial killings have been going on in Balochistan since early 2000's, when the central government started to suppress the voice of indigenous people of Balochistan on rights on their land and resources. Thousands have gone missing since then, hundreds of missing persons were found dead later.

May 2019

70 disappeared, 36 killed:

Seventy persons were picked up by military and forcibly disappeared. Eight of them were released later, while whereabouts of 62 civilians remain unknown.

Maqbool Yar Mohammad was abducted by personnel of Intelligence agencies from his house in Hub town of district Lasbela on 3 May. His family abandoned their native village, Mashkay Awaran, due to consistent military offences and was living a life of IDPs in Lasbela, the home district of Chief Minister of Balochistan, under the Imran Khan's new central government.

On 5 May, forces whisked away 17 years old Hammal Assa from his hometown Gomazi Tump, district Kech, the home district of previous Chief Minister of Balochistan, under Nawaz Sharif government.

Of the same village, Gomazi, fifteen years old Talal Dost Mohammad was picked up by military from a local transport vehicle, when he was traveling from Karachi to his home, on the same day. Both are cousins.

Salman Khudadad was picked up by military and forcibly disappeared from Mand Bullo, Kech on 7 May, from a local grocery, in front of the public.

On 11 May, security forces whisked away four persons, Murad Samad, Abid Khalid, Syed Abul Hassan and Waju Wahid, during a house-to-house search operation in Neyabad, Gwadar. Forces are accused of beating women and children during the operation.

On 12 May, Noor Khan Kahur, a fresh graduate from Balochistan University Quetta, was whisked away by the forces at around 3 AM local time from Essa Nagri, Quetta. He was

a resident of Shapuk, district Kech and was on a search for job in Quetta, the administrative capital of Balochistan.

Two students of the same region, Mekran, were whisked away by military from Brewery Road of capital city, Quetta. Security forces took Ashraf Neksal and Gulab Rozi from Mashallah Plaza, in front of dozens of people, on 15 May. Both were sent by their families from interior, war-turned regions to the capital city for safer and better education.

Military has abducted and disappeared more than a hundred students of Balochistan, from other cities of Pakistan, including Nawaz Atta, a human rights activist, Information Secretary of BHRO.

Rahmdil Pir Bakhsh of Hoshab Balochistan, a graduate in Philosophy was abducted by security forces in Karachi, administrative capital of Sindh. He was working with KASBIT University Karachi after completing his graduation.

The next day his cousin Nasir Azim was whisked away by security forces from the same house in Gulshan-e-Iqbal. Nasir is a resident of Absar, Turbat and a student of M. Phil in Karachi University.

On 20 May, forces raided house of Allah Bakhsh in Gwadar, Balochistan and dragged him away from the house. Three days later, the house was raided again and military took away his wife, Ayesha and two daughters, Mahtap and 16 years old Nazelah. Mother and daughters were released later while whereabouts of Allah Bakhsh remained unknown.

Forces raided house of Fateh Muhammad, father of Hammal Fateh, one of four suicide attackers who attacked the only five-star hotel in Gwadar, the home town of Chinese invested Gwadar Deep Sea Port. Four gunmen stormed into the Pearl Continental hotel and it took military 24 hours to clear the hotel. The attack was carried out by an armed nationalist group that often attacks Chinese interests in the region. Organization threatened China to take his hands off the region.

Fateh Muhammad and Nasrat, a cousin of Hammal were whisked away by the military and their whereabouts are still unknown.

Fourteen years old Kachkol, brother of another suicide attacker of PC hotel, was picked by military from his house in Hoshab, Kech on 25 May.

On same day, forces abducted Hafiz Pir Muhammad from Naimabad Parom, district Panjgur and forcibly disappeared. Hafiz was once disappeared in 2015 but released later.

Forces raided house of Mujib Rasool Bakhsh in the same area of Parom, district Panjgur on 26 May and took him away. His fate and whereabouts are still unknown.

Decomposed bodies of five persons were found dumped. All were beyond recognition.

"We have found and buried 131 decomposed bodies in this graveyard. We have three of such kind. We'll just put a number on the grave", said a person working for Edhi Foundation. "Hardly 5% of the persons would be identified by any means", he said in a BBC Urdu report.

Twenty armed nationalists were killed in different battles between the nationalists and military in different parts of Balochistan and five persons were targeted killed by unknown gunmen. Nationalists often blame the military of using private militias and street criminals to kill people.

One child was killed when an armed nationalist group fired to kill one of organization's surrendered commander, in Kech. Spokesperson of Balochistan Liberation Front said in a press note that his organization apologizes for the child and is ready for any cooperation family asks.

BLF is one of the many organizations fighting the military and want Pakistan to leave Balochistan. Organization has been known for its educated and democratic leadership and has been enjoying support of most of educated youths since its early appearance in 2004.

Silence over Balochistan has shaped military's attitude towards any rights movement all over Pakistan.

Military repeated same in Waziristan, KPK region on 26 May 2019. It attacked a peaceful rally, killing more than a dozen and wounding more than forty-five. Rally was organized by Pashtun Tahaffuz Movement, a rights group developed in Pakistan's KPK region. Leadership of the group- legislators the local people elected- were said to be the aim of the attack. One of the legislators, Ali Wazir went missing for a few days, after military arrested him from the attacked protest, while the other, Mohsin Dawar was declared a wanted man. He finally surrendered himself to a court of law.

PTM leadership face the same hard time with military leaders in Balochistan faced. Pashtoon leaders are lucky enough to resurface, being in jail, while the leadership in Balochistan was disappeared, killed and thrown on roadsides, or shot killed.

Military, it seems, wishes to control the minds of each individual and does not allow any space for the voices of people.

June 2019

44 disappeared, 27 killed:

Forty-four people were enforced disappeared and twenty-seven killed during this month. Since the reports we received are from Awaran, Kech, Gwadar, Panjgur, Khuzdar and Dera Bugti districts of Balochistan, the rest of the 26 districts remained inaccessible.

Bashir Sipa: On June 3, 2019, security forces raided a house in New Town Gwadar and forcibly disappeared Bashir Sipa. He is resident of Kuldan Dasht, district Kech.

Abbas Rafiq and Shahzaib Jan Mohammad: On June 2 the forces whisked away two persons, Abbas Rafiq and Shahzaib Jan Mohammad, from Shahrak area of district Kech in separate raids. Abbas is a disabled person and is paralyzed from the waist down. Shahzaib is a final year medical student of Bolan Medical College Quetta and was in his hometown for Eid holidays.

Najib Noor, Rizwan Rahi, Adil Baloch, Naim Deedag and Bilal Baloch: On June 8, forces whisked away and disappeared 5 students from a house in Gwadar city. They are identified as Najib Noor, Rizwan Rahi, Adil Baloch, Naim Deedag and Bilal Baloch. Bilal Baloch and Rizwan Rahi were later released whereas the whereabouts of the others are still unknown.

Yasin Basham: Yasin Basham was abducted by unknown gunmen from University roundabout in Bhawalpur Punjab. He is a student of Bio-Chemistry in Bhawalpur University and resident of Turbat, district Kech.

Bashir Ahmed: Bashir Ahmed s/o Faqir Mohammad is a resident of Nokjo Mashkay, district Awaran and a Mason by profession. According to details local death squad members invited him to build a house. He went to Gajjali for work and didn't return the same day. Next day on June 27, his dead body was brought to the local hospital. According to hospital sources, his body bore signs of severe torture.

It is nearly impossible for anyone to raise their voice against the enforced disappearances in Balochistan and other human rights violations perpetrated by the army due to the risk of immense persecution faced by those who speak against army impunity. But in an unusual incident occurring in June 2019, a campaign against enforced disappearance prevalent in Pakistan, held in London, was attacked as well. A mob, on 23 June, of ostensibly Pakistani civilians attacked a protest campaign outside the United Kingdom's Lord Cricket Stadium where Pakistan's national cricket team was playing against South Africa. The mob attacked Balochistan exiled activists and tore

down all the banners and play cards which read "Help End Enforced Disappearances in Pakistan".

Attackers included a couple of persons who were previously accompanying the Pakistan army chief, General Bajwa, and the DGISPR Asif Ghafoor, as shown in the video footages circulating in the social media.

Farhatullah Babar, a senator and well-known human rights activist disclosed in a tweet that the Chairman of Commission on Enforced disappearances has proved that the security forces are involved in the practice of enforced disappearances.

He said: "Chairman Commission on Enforced Disappearances recently admitted before a Senate committee of identifying 153 security persons involved in it. He should now tell whether and what action taken against them..." Despite such a huge disclosure from a sitting senator, the subject got much attention neither in parliament nor in national media of Pakistan.

This dire situation of human rights is pushing the people of Balochistan to the wall with every passing day. Hundreds of thousands of people are displaced due to continuous military operations and the resultant environment of fear. These internally displaced refugees are living without shelter in harsh weather of Balochistan often without food and drinking water. Many others have fled to Afghanistan and Iran living a similar miserable life. No humanitarian organization has so far initiated any aid or listing of these displaced war-effected people.

July 2019

46 disappeared, 16 killed:

At least a hundred cases of enforced disappearance and over a hundred cases of extrajudicial killings have come to our notice since the beginning of July.

As most of Balochistan remained unaccessbile to independent journalists and human rights groups, we could only confirm details of 46 cases of disappearance and 15 killings in seven districts out of Balochistan's 32 districts.

Being loyal to its years-old practice, security forces sieged villages and detained men on suspicion. Some were later released soon while the rest are missing.

Pakistan's military bosses have been waging a ruthless counter-insurgency war against a separatist Baloch movement in the country's largest province of Balochistan.

Thousands of Baloch politicians, student leaders, human rights activists, teachers and separatist militants have been forcibly disappeared and some of them killed in custody. Tortured and bullet-riddled bodies are often found dumped in the hills and plains of thinly populated Balochistan.

On 02 July, security forces abducted and forcibly disappeared Helál s/o Ghulam Jan a resident of Ball Samathi village of Dasht, district Kech, during a raid on house in Mondi area of district Gwadar. He works in Gwadar Development Authority, a project named by government after the indigenous people opposed building a deep-sea port in the town. The port connects Pakistan's deep waters to China's Kashghar port via road part of China's Belt and Road Initiative. No one heard of him since then and his whereabouts remained unknown to the family and office.

Another watchman of Gwadar Port, Anis Latif of Kombél, Dasht was abducted and disappeared by military on the same day. He was picked up from his workplace, in front of other staff.

On 03 July, forces whisked away Ayaz Nabi Bakhsh, a resident of Alandoor area of Buleda district Kech, from Karachi's Jinnah International Airport as his flight landed from

Dubai, UAE. Family says they have lost contact after he flew from Dubai. He is missing since then.

On 05 July, forces raided a house in Saidabad area of Kilkor, district Panjgur and abducted Hakeem Ghulam.

On 07 Jul, forces forcibly disappeared Rasool Bakhsh Hassan resident of Gichk Darkop, Panjgur from main bazar of Panjgur.

On 08 July, seventeen persons were reportedly disappeared from different areas of Dera Bugti during a military operation in the region. The abductees include women and children. Region is not accessible and we could get partial details of six persons out of seventeen. The identified victims include Hamidullah, Nasibullah, Pir Ali, 70 years-old Soori Mirza Khan and two women, Mehr Bibi and Noor Bibi. According to sources, Pakistani forces burned down their houses and looted the valuables including 300 livestock.

On the same day military abducted Mutalib Abdullah resident of Nayabad Area of Gwadar, during a raid on his house in Gwadar town.

On 09 July, forces took away a 12-years-old boy, Balaach Hasil from a local van, when he was traveling from his hometown Karki, Tejaban area of district Kech to Turbat town.

On 12 July, forces whisked away Abdul Ghani Muhammad yousuf from Asiabad, Tump, district Kech, when he was coming back to home from Dubai.

Forces raided a house in Konshkalat area of district Kech and forcibly disappeared three persons including two brothers, Zafar & Zarif Dur Muhammad. The other victim was identified as Javed Dad Rahman.

Military raided two houses in Shahrak area of district Kech and abducted Arif Washdil and Baran Dad Bakhsh from their houses, in front of the family members and other villagers.

On 15 July, Navid Musa and Shehzad Tariq were abducted by military from their homes in Dazin area of Tump, district Kech.

On the same day, forces stoped a local bus In Hub Chowki and forcibly disappeared a passenger, Haji Hussain Noor Muhammad who was coming back home from Karachi. He was sick and visited Karachi for his treatment.

On 15 July, Zubair Kashmir resident of Bostan, Tump, district Kech was picked up by security forces from an auto repair workshop in the village.

On 16 July, forces abducted Maqbool Rafiq, a resident of Segek area of Kolwah, district Awaran. He was going to Kolwa from Turbat when he was stopped near a military check-post in Hoshap and then whisked away by the forces.

Twelve persons went missing from Dakhi Bazar area of Absar district Kech during a Raid. Six of them were identified as Parvez Ayoub, Sharif Suleman, Zahid Walid, Hafeez Hatir, khalil Pullain and Shaihaq Mohammad Salim while families of other six persons did not want to report the cases, in fear of losing their loved ones.

On 19 July, three persons went missing from Washbod area of Panjgur after military raided the village and took away the men. Shafiq Baloch, Abid yousuf and one more person were disappeared by military after the raid.

Next day, on July 21, forces raided a house in Nezarabad area of Tump, district Kech, picked up Mir jan Master Rafig and moved him to unknown location.

On the same day, forces whisked away Jumma Abdul Ghafoor, a resident of Okar Jewani, district Gwadar from Kontani Hor area of Gwadar.

On 22 July, forces raided a house in Zomdan area of Pirandar, district Awaran and forcibly disappeared Badal Sher Muhammad during a raid.

On 23 July, six persons were forcibly disappeared during raids in various areas of Balochistan. Four of them, Sakhi Dad, Wazir Nambo, Hashim & Waheed Dil Murad were taken away from Ziarat e Dann area of Pirandar, district Awaran. Beebagr Noor Muhammad was abducted from Mulla Chaat area of Mand, district Kech, while Tahir Khan Muhammad was whisked away by military from Meskan Metag area of Pirandar, district Awaran.

On 24 July, forces raided the house of Qayum Syahok in Asiaabad, Tump area of district Kech and forcibly disappeared him.

On the same day, forces raided another house in Koh e Sar Metag, Jewani area of district Gwadar and whisked away Ata Abdul Razaq.

On 29 July, security forces raided a house in Srenken, Tump area of district Kech and whisked away Imtiaz Baloch.

The dead:

Six decomposed bodies were found dumped in three different areas of Balochistan during the month of July. Only one could be identified as Rehmat Gulab Khan. His body was found in Quetta, Balochistan's capital, on 08 July.

Three decomposed bodies were also found in Panjgur, where two mass graves have been previously discovered that contained bodies of victims of enforced disappearances.

In one of the Panjgur's mass graves discovered in 2011, locals found the bodies of three previously missing persons. Abid Shah, aka Agha, a student leader of the Baloch Students Organization was one of them. He had been taken away by the security forces in 2010.

More than a hundred dead bodies were found dumped in another mass grave in the district, discovered in 2014. One of the dead was identified as Naseer Ahmad, who had

been abducted by Frontier Corps, a paramilitary force in Balochistan, from the marketplace of his village in front of several witnesses.

Reports have confirmed that more 131 unidentified decomposed bodies were buried in one of three graveyards near Quetta in the last 26 months. Only five of them could have been identified. All those unidentified bodies were later buried by a charity organization in a brand new graveyard with digits instead of names on each gravestone.

August 2019

32 disappeared, 18 killed:

Thirty-two people were forcibly disappeared by Frontier Corps, a paramilitary force, in five districts of Balochistan in the month of August while 18 people were killed during the same period.

The Pakistan military has turned its southwestern province into a war zone since early 2000's to suppress a nationalist movement. The relatives and human rights groups accuse the military of forcibly disappearing and killing thousands of political activists, students, journalists and others.

On 01 August, six students were taken away by security forces during two different raids in Kech district's Turbat area and Panjgur's Chitkan area, separately. Piral Bashir Ahmad, Sajid Dinar, Sher Jan Yousuf and Alim uddin Mustafa were taken away from Turbat, whereas Abdul Karim Shamim Ahmad and Nasrullah Shabir were from Chitkan, Panjgur. a Security forces, on 05 August, picked up a resident of Malikabad, Tump district Kech, Ali Hakim, whose whereabout remain unknown to this day.

Uzair Allah Dad was forcibly disappeared along with his sons from Mashkay, Awaran, during a raid at his house on 06 August.

On 08 August, Ali Abdul Rahim was taken away from Ormara, district Gwadar. He is a resident of Jhao, district Awaran.

On 17 August, security forces conducted multiple early morning raids in Jattani Bazar, Dasht district Kech. In a house-to-house search, they harassed women and children, and detained Niaz Shambay.

In another raid the same day on Kalshan, Parom, district Panjgur, security forces also whisked away Shah Nizar Huda Nizar who is still missing.

Meanwhile, security personnel launched military operations in Kolwah, district Awaran on 20 August. The area is still under siege with all communication lines being blocked. No further information could be confirmed from the affected areas.

On 21 August, another military search operation was launched in Raghay, Mashkay district Washuk,in which six shepherds — Dad Karim Hammal, Sher Jan Abdullah, Huzoor Bakhsh Abdullah, Swali Dad Karim, Alam Khan Khair Mohammad and Ghos Bakhsh Gulsher – were detained and taken to an unknown military location.

Also, on 22 August, Adil Kalmati was detained in Jemari Bazar, Gwadar.

On 24 Aug, security forces raided Front Bazar, Dasht district Kech and forcibly disappeared six people — Rafiq Lal Bakhsh, Majid Khuda Dad, Mehbub Abul Hasan, Riaz Dad Mohammad, Nasim Saleh Mohammad and Dur Jan Abdullah.

Essa Shambay, who is 65-year-old, was picked up during a raid at his house in Zairati, Dasht district Kech, on 25 August.

Killings:

On 22 Aug, local aid workers in Noshki, Balochistan, found a decomposed dumped body which was later identified by doctors as that of Sarfaraz Jumma Khan, a local of Noshki. The doctors said the body was could be 22 days old.

On 27 Aug, another decomposed body was found dumped in Kolwah district Kech. The body was later identified as that of Asad Bebagr. He had been abducted by security forces almost a month ago with another person whose whereabout remain unknown.

September 2019

32 disappeared, 19 killed:

Military backed death squad members picked up Usman Maqbool from Pidrak area of district Kech on 4 September, 2019. He is missing since then.

On September 24, death squad militants from a different group picked up a teenage girl, Nazia, from Greshag Khuzdar. She was later released.

On September 7, gunmen abducted three persons — Jalal, Wazir and Jwanu– from Kilkore, Panjgur.

Human rights groups and locals have often accused military of harnessing such death squads in Balochistan to counter a nationalist insurgency simmering in the region for over a decade.

However, other victims were picked up by personnel of Frontier Corps (FC), a paramilitary force.

On September 1, FC personnel forcibly disappeared Abdul Qadir Abdul Samad and Tariq Mohammad during a raid in Gomazi, Tump district Kech.

On September 4, FC conducted an operation in Killi Jalazai and Killi Ghozai area of district Kharan and forcibly disappeared four persons — Saifullah Mengal, Dr. Abdul Sattar Pirkazai and his two sons, Kamran Sattar and Farooq Sattar. On the same day, Saddam Warna was abducted and disappeared by the security forces from his garment store. He had previously been taken away by the FC in 2016, but was later released.

On September 4, a student, Adil Murad Jan was whisked away by FC from a shop in Sandani area of district Panjgur.

On September 10, FC raided a house in Hor area of Dasht, district Kech and abducted 60 years old Abdul Hassan Khudadad.

On September 11, Naim Ghafoor, a resident of Gwadar was whisked away from his Shop.

On September 14, the security forces abducted five persons during a raid in Machat area of Dasht, district Kech. The victims were Arif Madi Han, Peroz Ghulam Hussain, Kabir Amir, Nazir Maula Bakhsh and Maula Bakhsh.

Separately, on the same day, two others were forcibly disappeared by FC from a check-post in Pidrak area of district Kech. The abductees were Maula Bakhsh Dur Muhammad and Adil Assa.

On September 17, two residents of Tank area of Mashkay, district Awaran, Shahjan Abdul Karim and Faiz Dilmurad went missing from army Camp where they were called to appear and then disappeared.

Similarly, Hasil Hassan resident of Pittok area of Dasht, district Kech was asked to appear in FC camp on September 19. He went to the camp and never came back. He had previously been picked up by the FC, two months back.

On September 21, FC laid siege to Gandchai in district Awaran and forcibly disappeared several locals. Only five of them could be confirmed as Qadir Bakhsh, Elahi Bakhsh, Ali Bakhsh, Manzoor and Ghulam, while the details of the rest are yet to be confirmed.

On September 26, Sharif Haji Muhammad Ali was taken away by personnel of FC during a raid on his house in Kombel area of Dasht, district Kech.

On September 28, Abdul Qadir Fazal resident of Essai area of district Panjgur, was forcibly disappeared by FC from his workplace, the telephone exchange.

On September 29, two persons were abducted by Frontier Corps. One was identified as Jafar Hussain, resident of Panjgur, who was a trader of Iranian petrol and diesel. The other victim is Sohail Huzoor resident of Katagari area of Panjgur. He was working in Dubai and had come home on his vacations.

Killed persons:

On September 29, personnel of Frontier Corps, brought the tortured body of Zafir Baloch, resident of Chedagi Awaran. He had been abducted and disappeared by the same force a few days back and had been tortured to death. Zafir was a local leader of the Baloch National Movement (BNM), a political party campaigning for right of self-determination for the people of Balochistan. A number of party's top leaders have been killed by military, including its founding chairman Ghulam Muhammad Baloch and central general secretary Dr. Mannan Baloch.

On September 9, the tortured body of Hammal Murad resident of Gazzi area of Mashkay, district Awaran was buried under supervision of the security forces. He was abducted on August 20 and remained missing since then. In another incident on same day, military backed death-squad shot killed Mir Muhammad Ali in Grai, Ragay, district Washuk.

Hundreds of decomposed bodies have been found in Balochistan since early 2014. Most of them are beyond recognition and are buried without their identity being established.

It continued in September too. On September 2, a tortured body was found in Laddi Dasht area of district Mastung. The body was moved to hospital for autopsy but his identity could not be established.

On September 26, a decomposed body was found in Charda Chowk area of Panjgur. The body could not be identified till the time of filing this report.

On September 5, a decomposed body was recovered near a fisheries pond in Dera Murad Jamali. The deceased was moved to hospital and later identified as Muhammad Afzal. The body was later handed over to the family.

On September 10, the decomposed body of Agha Muhammad Ghulam Qambarzai was found dumped. He was a resident of Pad-Gayaban, district Chagai and was abducted and disappeared.

On September 19, the decomposed body of Ayaz Sardu was discovered from Menaz, Buleda, district Kech. He was abducted few days before by unknown persons.

On September 4, unknown armed men gunned down Jamshed Takkari in Hazarganji, district Quetta.

On September 10, the local death squad members killed two persons, Bahdad Shahdad and Jalal, residents of Lop e sar, Balgetar, district Kech.

On September 21, unknown armed persons opened fire and killed Hazah bugti and his wife where two children were badly injured in Sui, district Dera Bugti. On the same day, six persons including a woman were killed during an intelligence-based-operation by the security forces in Quetta. The IG of police said that they were militants Of ISIS but details of the persons and their involvement were not made public.

On September 5, unknown gunmen killed two persons in different areas of Balochistan. Muhammad Karim Gazgi was killed in Gazgi area of district Khuzdar and Sarwar Ahmad in Chaman, Balochistan.

October 2019

20 killed, 12 disappeared:

At least 20 people were killed and 12 forcibly disappeared in different areas of Balochistan, as the military continues its crackdown against a separatist insurgency in the region.

Four persons, who had been previously abducted by "unknown gunmen", were found dead in October 2019.

"Unknown gunmen" are masked men, who locals believe are sponsored by the military to target families of Baloch insurgents and political activists.

On 5 October, a bullet-riddled decomposed body was found in the Mandig Kaor area of Mand, a town in district Kech that borders Iran. The body was identified as that of Ali Akbar Akram. He had been previously abducted by members of local death-squad. The body bore marks of severe torture.

On 7 October, two bodies were found in Turbat. They were later identified as Saddam Dashti and Masud Murad. Both were abducted by "unknown gunmen" from separate villages a day earlier.

On October 4, the decomposed body of Maula Bakhsh Abdul Wahid was found in Zangi Nawad area of district Nohski.

Also, four men are shot killed by "unknown gunmen" in Balochistan during the month.

On October 7, masked gunmen gunned down a Hindu merchant, Ashok Kumar in Jumma Khan Hotel, district Lasbela for unknown reason.

On October 8, Rahim Bakhsh, a resident of Gichk Kahn area of district Panjgur, was shot dead by unknown gunmen while another person, Nizam was injured in the incident.

On October 12, Mujib Jami resident of Kashap, Dasht, district Kech was killed by unknown gunmen. According to the locals, he was a member of a local death-squad.

On October 15, unknown gunmen shot killed Anwar Ababaki in Hazarganji, Quetta. His father was abducted by the security forces in 2010, and is missing since then.

Besides, two unknown bodies were found in Quetta and one in Lasbela regions of Balochistan in October.

On October 3, an unidentified body was found in Killi Qambarani, district Quetta, and was then moved to hospital for further investigations.

On the same day, the body of a woman was found in Killi Khali near Khezai bypass in Quetta. The body was sent to hospital for medical examination.

On October 25, a decomposed body was found from Windar, district Lasbela near the motorway. The body was sent to the nearest hospital and then sent to the Edhi Foundation. The body was decomposed beyond recognition.

Enforced Disappearances

Enforced disappearance continued in the month of October. Dozens were abducted by personnel of Frontier Corps, but most of them were released later. Yet twelve of them remain missing till the time of filing this report.

On October 08, Pakistani forces abducted a 14-years-old boy, Nadim Darwesh, from Sakuran area of district Hub where he had been living for quite some time after his village, Kohado, in Jahoo, district Awaran was evacuated by military. Nadim is the fourth victim of enforced disappearance in the same family.

On October 12, Frontier Corps personnel conducted a raid in the Awaran region and abducted three persons — Dad Muhammad Baran, Sabir Lal and Elahi Bakhsh Hamza.

On 14 October, forces raided the house of Miskan Baloch in Babbarshor area of Pasni, district Gwadar and inquired about his son Hamid. Later, forces took Miskan to the

place where his son went for picnic and abducted his son while Miskan Baloch was let go.

On October 16, Muhammad Yaqub resident of Badokasht area of Jahl, Zehri, district Khuzdar was abducted by Frontier Corps in Surab while he was going to Khuzdar with his family.

On October 17, forces whisked away a student, Amir Jamaldini, a resident of Killi Bato, Noshki from Cadet College Noshki.

On October 18, personnel of Frontier Corps and intelligence agencies abducted Arif Irshad resident of Hoshap, Naseem Karim Bakhsh and Dil Murad Nasir, residents of Gwarkop from Koh-e-Murad, Turbat. The next day Naseem and Dil Murad were released while the whereabouts of Arif Irshad are still unknown.

On October 27, forces took away a resident of Ward No.1, Pasni, district Gwadar named as Irfan Ghani while he was on his way from Gwadar to Pasni.

On October 29, forces abducted Farid Fazal and Nadil Abdul Nabi during a raid in Maher area of Mand, district Kech. The military is constructing a camp in Maher and often raid local houses in search of suspects.

November 2019

31 disappeared, 15 killed:

Personnel of Frontier Corps abducted four women during three raids in different parts of Awaran on 29 November 2019.

They whisked away 52 years old Sakina Qadir Bakhsh from Harunay Dann, 47 years old Sayad Bibi Ahmad from Mashi, and 35 years old Hamida Mir Dilbod and 52 years old Nazal Mir Asadullah from Zilag village.

Next day, the abducted women were photographed along with two female police officers and a cache of arms and ammunitions which the police said they had recovered from the women's possession.

The police claimed the four women were 'facilitators of terrorists' and shifted them to Khuzdar Jail after booking them on terrorism charges.

Two of them were later hospitalized in Khuzdar due to severe physical torture.

We investigated the cases and found that the four women had been picked up because of the involvement of their male relatives in the ongoing nationalist insurgency. Security forces could not find the men during previous raids on their homes. Frustrated, they finally took away the women.

All of these families are among those internally displaced due to the conflict between insurgents and military. They had left their native villages because of continuous raids on their houses.

Security forces often lay siege to villages, abduct men and burn houses. More than a thousand of such abducted men have later been found dead.

This pattern is forcing men to stay away from home, especially during raids. Many have joined armed groups to find a shelter.

Abduction and enforced disappearance is not a new pattern in Balochistan. Tens of thousands of men have been abducted by security forces and are missing since early 2000's. Dozens of mass graves have been found in different parts of Balochistan, each containing 10 to 150 bodies.

The abduction of women tends to intensify the already simmering tensions between nationalists and the central government.

Some nationalist armed groups have issued press releases saying "they would not consider themselves bound to the international conventions and ethics of war, as Pakistan has already violated all the ethics by abducting our women."

Thirty-one more persons were abducted and forcibly disappeared by security forces during the month of November, according to reports received by HRCB and BHRO.

On Nov 1, the security forces raided a house in Cheri Malar, district Awaran and forcibly disappeared Dosten Riaz.

On Nov 3, forces abducted Wahid Murad, a resident of Ashal area of Kolwah, district Awaran from a shop in Turbat, the district headquarter of Kech.

On Nov 6, Ali Hanif was abducted and forcibly disappeared from Soro area of Mand, district Kech.

On Nov 9, forces abducted Saghir Saleh Muhammad and Talal Imam Bakhsh from Goburd area of Mand, district Kech.

On Nov 10, FC raided Macchat village of Dasht, district Kech and abducted Usman Sakhi and Sharif Salim.

On Nov 17, Ubaid Arif, a Balochi writer and poet was whisked away from Jattani Bazar village of Dasht, district Kech. He was working in UAE and had come home on his vacations.

On Nov 18, FC raided a house in Singabad area of Kech and abducted Miran Sardu along with his son, Haleef Baloch.

On Nov 25, FC personnel whisked away 70 years old Kachkol Ali at a military checkpost when he was on his way from Kech to Panjgur.

On the same day, forces abducted and disappeared two students, Sajid Qadir Bakhsh and Parvez Sadiq, from Haroon e Dan area of district Awaran. Sajid is the son of Sakina, one of the four women still in police custody.

On Nov 26, security forces abducted a student from the Hub Chowki area of district Hub and moved him to an unknown location. The victim is Sarwar son of Abdul Qadeer, a resident of Kohado area of Jahoo, district Awaran. He had recently moved to the Hub city with his family.

On Nov 28, FC abducted and disappeared thirteen persons from Lakhanadi, Uch area of district Dera Bugti. We were able to get details of seven of them as we await to confirm the rest.

On Nov 28, FC raided a house in Parom are of district Panjgur and abducted Mukhtar Ghulam Rasool.

On Nov 29, the forces abducted two others from separate areas of Balochistan. Noor Dad son of Arz Muhammad was taken away from Ormara, Gwadar, and Taj Muhammad son of Eid Muhammad from Mand, district Kech.

On Nov 29, forces raided another house in Parom and forcibly disappeared four persons, Muhammad Ghulam Hussain, Barkat Liagat, Aziz Ali Bakhsh and Shero Issa.

Killed persons:

On Nov 4, a dead body was found in district Qilla Abdullah. It was immediately moved to hospital where he was identified as Gosullah Karim Agha. He had been abducte d on 14 Aug from Shaikh Mandha, district Quetta and had been missing since then.

On Nov 10, three dead bodies were found in Gardank area of Buleda, dictrict kech. They were identified as of Niamat Abdul Karim resident of Zamuran, district Kech, Salauhddin

Inayatullah resident of Khudabadan, district Panjgur and Zubair Badal Khan resident of Kharan.

On Nov 19, a dead body was recovered from Quetta. He was later identified as Ahmad Zia Navid Khalji resident of Nawa Killi, Quetta.

On Nov 29, another dead was found in Washuk, who was identified as Kamal Khan Bahadur Shah resident of Kharan.

Two decomposed bodies were found in Quetta and Qalat on 19 and 28 November. Both were beyond recognition and were buried without establishing their identities.

December 2019

64 disappeared, 11 killed:

December saw a surge in the number of people who were forcibly disappeared in Balochistan. Some 64 persons, including two elderly men and four students, were taken away by security forces.

Meanwhile, 10 people were killed in different incidents and a decomposed dead body was recovered from district Duki.

On Dec 2, the forces disappeared a student, Shahnawaz son of Babu, a resident of Ronjan, Mashkay area of district Awaran. His family was threatened into brining him to the army camp in Mashkay. His uncle took him to the camp from where he was forced to leave without Shahnawaz, who is still missing.

On the same day, security forces abducted six others from different areas of Kech and Awaran. They were identified as Waris son of Ibrahim, Muhammad Jan son of Adam,

Haleem son of Muhammad, Usman son of Allah Bakhsh, Badain son of Hamza and Qadir Bakhsh.

On Dec 3, security forces raided the house of Khalil son of Abbas in Shand area of Mand, district Kech, and took him away after a brief detention.

On Dec 4, Misk Ali son of Lala Bugti and Rasool Bakhsh son of Rameen were whisked away from Rahi area of Naseerabad during a military raid.

On Dec 6, secret agents abducted Haji Sher Jan son of Laal Khan, a resident of Senganisar area of Turbat, district Kech. He was a retired Dubai policeman who worked for 30 years and was visiting for medical treatment. He went missing from the Karachi airport. He had also been previously forcibly disappeared.

On Dec 7, the forces took away a student, Jalal son of Hassan, and Keyya son of Ali from the Gomazi area of Tump, district Kech, during a search operation. He is since missing.

On Dec 8, military forces carried out a search operation in Hor, Dasht, district Kech, and abducted Akbar son of Madi Khan and another person whose identity couldn't be confirmed.

On Dec 9, local death squad militants abducted a teenaged boy, Khairullah son of Abdul Samad Laangav, from Tootak, Khuzdar.

The same day, the forces picked up Rasool Bakhsh son of Nazeer and Shabeer son of Noor Bakhsh during a raid in Zandain Daz area of Panjgur. His whereabouts remain unknown.

On Dec 10, the forces conducted a search operation, laying siege to Jahoo, district Awaran, and whisked away 11 people. The abductees were identified as Mullah Muhammad Kareem son of Sher Jan, Jumma son of Malik, Kameesa son of Lakko, Nabi Jan son of Gul Dad, Faqeer son of Hassan, Muhammad son of Eido, Rasool Bakhsh son of

Ibrahim, Qadri son of Biyandar, Khudadad son of Noora, Jumma son of Hadoo and Muhammad Umar son of Lakko.

On Dec 12, the forces raided the house of Muneer son of Murad Bakhsh in Kaleera area of Dasht, district Kech, and took him away.

On Dec 13, the forces carried out a raid on the house of Ishaq son of Ibahim in Jitani Bazar, Dasht, district Kech. They beat up the women and took Ishaq away. It is the second time he has been forcibly disappeared.

The same day, the forces whisked away six persons from a bus stop in Hazarganji, Quetta. They were travelling from Naseerabad for medical treatment. Later, the others were released but 60- year-old Haji Dost Ali and 80-year-old Fareed are still missing.

On Dec 17, the forces abducted Kareem Dad, his son Murad Jan and son-in-law Umar from Bagod area of Mashkay, district Awaran. Also, they took away Majid Baghwan from Nokabad area of Gramkhan, district Panjgur.

On Dec 19, the forces picked up and disappeared Mama son of Murad Khan Marri and Raza Khan son of Mullah Qambrani from Killi Tangai, Shahrag, Harnai, district Harnai.

On Dec 20, Abbas son of Ibrahim and Waleed son of Hamza were forcibly disappeared during a raid in Mullahi Nigor, Dasht, district Kech, by military forces.

On Dec 21, the military forces raided a number of houses in the Gomazi area of Tump, district Kech, and took away five residents of the area. The victims were identified as Taimur son of Anwar, Basheer son of Haji Rehmat, Ayoub son of Rasool Bakhsh, Naseem son of Dr Dur Muhammad and Zubair son of Liaqat.

On Dec 22, the forces raided a house in Tayabdapi area of district Gwadar and whisked away Wahab son of Ghulam Muhammad, a student in Quetta. He had come home on vacations.

On Dec 23, Qadeer son of Barkat went missing when the security forces raided his house in the Malar area of district Awaran and dragged him away.

On Dec 25, the forces conducted a search operation in Awaran and abducted eight locals — Pullain son of Hassan, Maula Bakhsh son of Peer Jan, Akbar son of Maula Bakhsh, Hassan son of Siddiq, Murad son of Hassan, Nadeem son of Allahyar, Barkat and Yaseen sons of Ameen. The identity of two others could not be confirmed.

The same day, intelligence personnel whisked away a resident of Damb, Hoshab, district Kech namely Shakar son of Sordo. Meanwhile, FC personnel raided the house of Haneef son of Swali in Malar, Awaran and took him away.

On Dec 26, intelligence personnel forcibly disappeared Aseel son of Ismail who was a resident of Sardro, Panjgur. He was picked up from the Diesel Market where he had been working for over a year.

Killed persons:

On Dec 1, unknown militants opened fire on Ameer son of Bashir, a resident of the Gichk area of Panjgur, and killed him. Another person, Nizam, was also injured in the incident.

On Dec 3, unidentified gunmen killed Abdul Rasool son of abdullah in Saryab Mill area of Quetta for unknown reasons.

On Dec 13, unknown armed men shot down Rafiq son of Muhammad Ismail, a resident of Tadeek area of Noshki. The reason behind the murder remains unknown.

On Dec 18, unknown militants opened fire on Mehboob and his son Danish. According to the locals, they were working for the Pakistani forces.

On the the same day, during a skirmish between Pakistani forces and Baloch militants, two members of the Baloch Liberation Front (BLF) namely Sameer and Dedar were killed. They both belonged to the Badrang area of Kolwah, district Awaran.

On Dec 19, a decomposed dead body was recovered from the Ishkarchat area of district Duki and was immediately moved to hospital for medical examination. No further information was provided about his identity by the local government.

On Dec 22, one was shot dead by the police for not raising his hands on the orders of the police.

On Dec 23, Yar Muhammad, a resident of Meherabad area of Surab was killed by unknown gunmen. The reason behind his death is unknown. On 26 Dec, gunmen killed Waqar Fida son of Fida Ahmad, a resident of Khudabadan, Panjgur for unknown reasons.
